1.1 The Early Intervention Foundation is a registered charity in England and Wales (registered number 1152605), and is a company limited by guarantee registered in England and Wales (company number 0866785) our registered office is at Local Government House, Smith Square, London, England SW1P 3HZ.

- (a) This Site provides information, materials and tools relating to early intervention. Written, video and audio resources may be available. Any materials, publications or information made available by EIF through the Site or otherwise are referred to as “Materials” in these Terms and Conditions.
- (b) These terms will apply to all users who view the Site or download any materials or publications (“you”). Please note that these terms govern both your use of the Site and your use of any publications or materials which you obtain from EIF, whether from the Site or otherwise.
- (c) By using the Site, you agree to be bound by these Terms and Conditions.
- (d) You are responsible for ensuring that all persons who access or use our Site or Materials via your internet connection or as part of their employment or engagement with you are aware of these Terms and Conditions, and that they comply with them.
