What is the research about?

The purpose of our research is to explore effective approaches to supporting families in local areas. This project is being run by the Early Intervention Foundation (EIF), and the funding comes from the **Department for Levelling Up**, **Housing & Communities' Supporting Families programme**. This work is focused in four local areas, but will generate lessons of value nationally.

The focus of the evaluation in Somerset is the 'proof of concept' pilot where Somerset West and Taunton housing officers will have access to Somerset's Transform Data View which provides information on an individual and their whole families' current situation, their vulnerabilities as well as their historic and current involvement with other services.

As part of the research, we will be carrying out interviews and small group discussions with local area staff who are using Transform Data View. We may also invite you to take part in other research activities, such as a survey or observations, as part of this research. We would like to emphasise that the research we are undertaking is about understanding your approach and how it supports families and is not about evaluating your performance or that of your local practice and training.

Who are the Early Intervention Foundation?

EIF is an independent charity and What Works Centre which champions and supports the use of effective early intervention for children. You can find out more about EIF on our website: http://www.eif.org.uk/

What will an interview or group discussion involve?

We will invite you to take part either in an interview or small group discussion lasting for around one hour. The interview or group discussion will take place either online, by telephone or face-to-face and will be arranged at a time convenient to you.

The discussion will explore your views on training and early use of Transform Data View, including any challengers and enablers for implementation. We will also explore early insights on potential benefits for practitioners, including perceived changes in practice when working with families, and outcomes for children and families.

Is participation voluntary?

Yes, participation is completely voluntary. You can decide not to take part in an interview or group discussion. If you do decide to take part, you may choose not to answer certain questions or to end the interview or group discussion without giving a reason.

Whether you decide to take part in the interview or group discussion, or in any of the research (survey, observation, etc) or not will in no way affect you or your local area.

What information will you collect?

With your permission, interviews/group discussions will be recorded using a secure digital recorder or via Microsoft Teams if taking place online. Recordings will be password protected where possible and will be uploaded to a folder which can only be accessed by the research team. Recordings from the digital recorder will be sent to a transcriber by a secure portal. The transcriber is fully GDPR compliant. Recordings from online interviews and group discussions will be transcribed by Microsoft Teams. All names and other identifiable information will be removed from transcripts.

When we write our report, we may quote something that someone says during an interview or group discussion, but we will keep all quotes anonymous. We may ask for examples of your work with families to illustrate the work you carry out. During the interview or group discussion, you may decide to refer to family members by their initials or by a fake name to keep the information you are sharing anonymous. We will remove all identifying information, such as names, in the transcript.

What will happen to the information that is collected?

The data that is collected will be treated in accordance with the Data Protection Act 2018.¹ Data will be stored securely and will only be accessed by the research team. Any personal data will be destroyed by the end of December 2022. Anonymised data will be kept for two years after the final date of completion of the project. The end date of the project is scheduled for July 2022 therefore all data collected for this project will be destroyed at the end of July 2024.

Information collected will be used for research purposes only and will help us to understand how your local approach works in practice. At the end of the research, we will use the data we have collected from evaluation activities to write an anonymised report. No information that could directly identify participants will be used in the report. The findings will make an important contribution to the evidence for future policy development in this area.

Will the information be shared?

The information we collect will be kept within the research team and will only be used at aggregate level with other data to write our report. We will not share any personal data we collect with anyone else. We will only disclose your personal details if you tell us something that indicates there might be harm to you or others, a safeguarding or child protection issue or whistleblowing and/or malpractice issue, or if we are required to for legal reasons.

Who can I contact with a query or a complaint?

Where we are processing your personal data with your consent, you have the right to withdraw that consent. Evaluating Somerset's Transform Data View: Staff interview/group discussion – topic guide

Aims of the evaluation

The purpose of the evaluation is to explore implementation of Transform Data View -a database of families including current and historic service support and assessments - to Somerset West and Taunton (SWT) housing teams that is being piloted in Somerset. The pilot will inform the roll-out of providing the Transform Data View to other district councils and 25+ RSL's in Somerset from 2023 onwards when the council becomes unitary.

Interviews with housing officers will aim to understand early implementation, including views of the training, TDV, and challenges and enablers for implementation. We will collect early insights on potential benefits for practitioners, including perceived changes in practice when working with families, and outcomes for children and families.

About this topic guide

This topic guide is designed to act as a series of prompts to the interviewer to ensure full coverage of all the research objectives. The interview/focus group will be conversational in style and will develop and expand on topics brought up by the participant. It is not a predefined list of questions and does not use all the follow-up probes that will be used throughout the interview. Each topic area will, however, be fully probed, as far as is feasible, during the interview/focus group. The order of the sections may differ between interviews/ discussion groups as the researcher will be led by the participant and what they seem comfortable talking about at that point of the interview.

The interview will last for around 1 hour and the focus group around 1.5 hours.

Introduction

- Introduce interviewer/facilitator
- Introduce EIF an independent charity and What Works Centre which champions and supports the use of effective early intervention for children
- · Thank participants for agreeing to take part
- Introduce the study:
 - » Research exploring effective approaches to supporting families in local early help services
 - » Funded by the Department for Levelling Up, Housing & Communities' Supporting Families programme
 - » Research in Somerset includes theory of change workshop, survey, and interviews and focus groups with those using/overseeing TDV.

- Refer back to the information leaflet and talk them through it to make sure they're happy with it. Emphasise:
 - » Participation is voluntary no right or wrong answers and can choose to have a break at any time or not discuss any topic.
 - » (if conducting a focus group) Interested to hear all views and experiences it's okay to have different opinions.
 - » Digital/online recording we would like to record the discussion so we have an accurate record of what is said. Only the research team will have access to the recordings. Data will be kept securely in line with GDPR.
 - » Findings will be used to inform evaluation reports which will be made available to them at the end of the evaluation later this year – no individual participant will be named in the report.
 - Reminder of interview/focus group length will last around 1/1.5 hour(s). Check if okay.

 - » Initial training

Interviewer note: to cover sections 4, 5, 6 + 7, begin by asking participants an open question to describe the times they have used tdv (eg 'can you describe a time you have used tdv when you have been working with a family?'). Then cover the probes in each section.

This will help us gather a rich narrative on how housing officers are using TDV and we will be able to include short case illustrations in the report.

4. Implementation of TDV

Aim: to explore participants views on the implementation of TDV, including challenges and enablers for implementation.

 - » Ease of access
 - » Senior management buy-in
- Challenges what has made using TDV harder? Ask open question first, then prompt if needed:
 - » Capacity and time to use TDV
 - » Missing/inaccurate data
 - » Engagement of other partners

- » Senior management buy-in/support
- » Not clear need to use it in work
- How have challenges been addressed?

5. Views on TDV

- Views/feelings about accessing and using TDV
- Strengths/weaknesses of TDV
- Any gaps in the data
- Suggested improvements

6. Perceived outcomes for families

Aim: to explore participant's views on the outcomes of TDV for housing officers.

- Brief profile of families they work with
 - » Types of challenges that are presented
- Added value of TDV for families
- Views on the benefits for families. Ask open question first, then prompt if needed:
 - » More timely support
 - » Tailored support
 - » Redcution in anti-social behaviour
 - » Reduction in rent arrears and evictions
 - » Housed in suitable/safe housing
 - » Increased stability
 - » Improved wellbeing
- Any disadvantages/negative impacts for families/parents/children. Ask open question first, then prompt if needed:
 - » Difficulties housing some families
- Whether outcomes vary by characteristics

7. Perceived outcomes for housing officers

Aim: to explore participant's views on the outcomes of TDV for housing officers.

- Added value of TDV for housing officers
- Perceived outcomes for housing officers. Ask open question first, then prompt if needed:
 - » Changes in practice
 - » Tailored support
 - » Relationship with other professionals
 - » Better communication
 - » More support
 - Relationship with families

- Any disadvantages/negative impacts for housing officers. Ask open question first, then prompt if needed:
 - » Time commitment to attend training/using TDV
 - » Overreliance on data rather than professional judgement

8. Close

Aim: to give participants opportunity to contribute any final thoughts.

End recording

- Thank participant for taking part
- Ask if any questions about interview/discussion or research more widely
